The admission and discharge form is a document in the clinical record, which identifies the assistance of hospital care, in a clearer way it can be said that it is the quality of work that they do or that is carried out within the hospital area, all This according to the modality of care, begins with the administrative task of admission and is given an end with the administrative task of discharge, this document is based on the responsibility that is shared with administrative staff, service and medical personnel discharge. The FIE is, to be able to fill it out, a review of the clinical record must be carried out since this will help us to guarantee that all the care, procedures or interventions provided to each of the patients can be consolidated in the form, which which helps to compile the information that is provided by the health facility, either to patients who only came for a review or those who came for something serious and had to stay because they had a therapeutic, medical or surgical procedure. This registry allows to keep an individual registry for each patient, taking into account the following data; sex, age, place of residence, main diagnosis, complementary diagnoses, diagnosis of external cause, disability caused by the incident you consulted, these data are very important, since through them we can know the current condition of the patient and whether previously passed through other medical sites, we have the knowledge that what kind of diagnoses have been made, this record is one of the sources for the generation of the country's epidemiological profile, Epidemiological report of the diseases subject to mandatory notification and the construction of national and international hospital indicators that allow evidence of the trends in the health of hospital care, as we all know that all hospital sites provide different services, which is why the reports are from It is extremely important since it helps us to know each of the services, the capabilities and the proper functioning of everything that is done or what they do within it, based on the data provided by the FIE, we can assess the costs according to the care provided in the different services and according to the modality of the hospital area. Day hospital, it can be said that it is like individual patient care, being in the place where they feel comfortable as being at home, it will also be understood as the care by which the

patient receives the surgical therapeutic techniques that he requires without having to leave his family or home, the patient is hospitalized for a certain period of time, the most common are twenty-four hours, during which the patient receives specialized treatments, device therapy, analysis, postoperative control, etc. There are people from the hospital group who have sufficient knowledge when giving therapies etc at home, since sometimes it is necessary to know how to use the devices that help the improvement of patients, but when it is not recommended that the patient have therapy in There is no need to do it at home, it is important that the more they get better, the later they will be able to return to their homes and to their family.
