## ” Nursing in the UK”

Today, nursing in the UK involves caring for the whole person. This includes emotional, psychological, spiritual and physical factors, not just an illness. Nursing care is based on the needs of the human being. In the 21st century, nursing has as its priority the well-being of the individual, providing good health management. For nurses, it is of total concern when a person is sick or has an injury. Advances in science have made nursing address complex issues of care and treatment to provide a better care service. Nursing in the United Kingdom is a regulated professional occupation with a comprehensive educational system that allows the acquisition of knowledge to meet changing needs. healthcare and the growth of complex treatments. Nurses in the UK base their practice on systematic assessment, planning, implementation and evaluation of care. Previously they were assigned a task depending on their seniority as a nurse as well as medication administration was done by senior nurses and simpler tasks by junior nurses. Personal cleaning was carried out by unqualified students and nursing assistants. This helps us understand how they practice nursing, what they do, where they work, and how the nursing process is used.

Nursing and midwifery are regulated by the Midwifery Council (NMC) its role is to: Keep a register of professionals (nurses and midwives) subsequently a new tripartite register was made which included nursing, midwifery and community specialists. The register has different separate sections for first and second level nurses, where the second level is for registered nurses and is closed to new applicants from the UK; however, it should remain open to all second-level nurses. Working nurses must complete registration with the Midwifery Council (NMC) to practice as qualified nurses in the UK; Registration must be renewed every 3 years to protect the public and ensure that nurses and midwives meet the minimum standards set. The NMC allows them to become registered nurses and midwives. In the event of misconduct, the NMC can act in a variety of ways and result in the doctor being removed from the professional register, preventing him from working as a registered nurse. The NMC developed a code of professional conduct where the responsibility of the professional and the rights of a person and health care are carried out, expectations are maintained to practice safely and effectively as a nurse. It is important that when practicing as a professional you have knowledge and understanding of the parts of the code of professional conduct, professionals who do not respect the code have to answer for their actions before the NMC including the hospital in which they work. The British public demands high standard and effective nursing healthcare. In the UK most nurses, midwives and students join an organization or union and there are some such as: The Royal College of Nursing, Unison, The Royal College of Midwives (RCM), GMB, Mental Health Nurses' Association. The most popular (RCN, UNISON). A union is one that works hard for the well-being and best interests of its nursing members. It also offers professional services and indemnity insurance for nursing members.

Employed nurses are covered by their employers' liability laws. Professional negligence is important for those nurses working in practice and for them the NMC recommends that they have adequate insurance and some unions offer continuing education to nurses through study days, courses or conferences, as well as the RCN and the RCM offer an extensive library. . Considering that RCN is one of the largest in the world. Most nurses and midwives work in the NHS (400,000) and (80,000) in the private sector, independent hospitals and care homes. In 1980 new nursing education programs called Project 2000 were introduced and this brought nursing education into higher education. The nursing sector and students were no longer considered part of the nursing workforce, which led to an increase in the employment of health assistants and assistants (ASS), who increasingly carried out more complex activities, so the nurse's role expanded and changed. Today, nurses work in hospitals and in the community and increasingly take on roles previously performed by doctors, ensuring faster care and more efficient service. UK employment legislation and guidelines help ensure fair and ethical employment practices. Qualified nurses with several years of experience receive adequate remuneration. It is important that at the start of their career or practicing at an advanced specialist level in the UK all nurses meet the five Cs of good nursing practice: competent nursing, commitment to nursing, confidence. in nursing research, compassionate nursing, and informed nursing awareness. Aspects of nursing practice need to be carried out to demonstrate competence, confidence, conscientiousness and compassion in an effective and high-quality manner. The care aspect of nursing work is the most important and appreciated by people, families and nurses in the world. In various parts of the world.

Nursing in the in the United Kingdom is one of the most difficult areas of work, but also one that best understands an individual. It is important to see how nursing has evolved over time and how a nurse's care goes beyond simply "curing diseases." "but it is seeing the emotional, the physical and the spiritual among others.
